Evidence of Net Income (after deductions)

- £22,700 for families outside of London with one child
- £26,300 for families outside of London with two or more children
- £31,200 for families within London with one child
- £34,800 for families within London with two or more children

This includes any wider income or support you may be receiving in addition to any earnings from employment. You will need to provide documentary evidence as proof of your income for both yourself and partner (where applicable) – this could be a bank statement, a pay slip or an employment contract.

In addition to these thresholds, families must hold no more than £16,000 in capital and savings.
